

SELINGROVE BOROUGH RESOLUTION NO. 2017- 08

RESOLUTION of the Council of the Borough of Selingsrove, Snyder County, Pennsylvania, as follows:

WHEREAS, on October 2, 2017, the Council duly adopted Selingsrove Borough Ordinance No. 829 which amended the Chapter 27, Zoning, of the Selingsrove Borough Code, by adding Part 20, Wireless Communication Facilities; and

WHEREAS, Section 27-2002 A.(2)(d) of Chapter 27, Part 20, of the Selingsrove Borough Code authorizes the Council to establish permit fees from time to time by duly adopted resolutions and

WHEREAS, the Council desires to establish a permit fee schedule herein as set forth below; and

NOW, THEREFORE, intending the foregoing paragraphs to be a part hereof, the Borough Council Resolves as follows:

RESOLVED, that Borough Council, as authorized in Section 27-2002 A.(2)(d) of Chapter 27, Part 20, of the Selingsrove Borough Code, hereby adopts the following permit fee schedule:

A. Permit Applications:

Non-Collocated Antenna (outside the right-of-way)	\$825.00
Non-Collocated Antenna (inside the right-of-way)	\$625.00
Collocated Antenna (PA WBCA)	\$675.00
Collocated Antenna (Non-PA WCBA)	\$825.00

Tower (outside right-of-way)	\$1,500.00
Tower (inside right-of-way)	\$375.00
Legal, Engineering, or Other Expert Review Fees	ABB

B. Annual Fees **Charge**

Tower (inside right-of-way)	\$1,000.00
Antenna (inside right-of-way)	\$375.00

RESOLVED, that the fee schedule set forth above shall be subject to modification from time to time by a duly adopted Resolution of the Borough Council as permitted in Section 27-2002 A.(2)(d) of Chapter 27, Part 20, of the Selinsgrove Borough Code

RESOLVED, FINALLY, that this Resolution shall take effect immediately upon its adoption at a regularly advertised meeting of the Borough Council.
