SELECTION OF CDBG Covid-19 Projects: Projects Proposed for CDBG-CV Funding

1. Selingsgrove Police Department – Urgent Need – Personal Protection Equipment, \$10,000
2. DH&L Fire Department – Personal Protection Equipment, \$6,000
3. Meals for Seals - \$5,000
4. Union Snyder County Action Agency – Rent/Mortgage/Utilities Assistance, \$37,646
5. Administration Fees – Seda-Cog, \$6,500

COUNCIL MEMBER – CP Mease provided Council with information pertaining the Selingsgrove Area Community Pool’s current repair situation. The pool has a leak which will require an extensive fix. A one season, temporary fix will cost \$15,700. After the season ends, the major renovation could begin pending fundraising which is needed to complete the \$175,000 job. There has been discussion of working to help the Selingsgrove Swim Team come back to the pool. Those costs add approximately an additional \$21,000 to the renovation costs.

MAYOR – Mayor Reed spoke to the Council about the need to fill a vacancy in the police department. C/P Kalcich made a motion to create an eligibility list for the police officer. C/P Mease seconded.
